### Introduction

The Tasmanian Family and Sexual Violence Alliance (TFSVA) is the peak body for the family and sexual violence sectors in Tasmania.

TFSVA provides a coordinated, strategic focus to family violence, sexual violence and child sexual abuse across the continuum of prevention, early intervention, response and recovery.

#### Vision

lutruwita / Tasmania is a place that is free from family and sexual violence, where all people experience safety, dignity and agency.

#### Mission

To transform the culture and systems that hold gender inequity and violence in place.

#### Values

## **Purpose**

The purpose of this Policy is to set out the processes, expectations, responsibilities and benefits of various membership options with the TFSVA. It includes the requirements to be considered a 'Full Member', and what benefits members can expect.

## Scope

This policy applies to all members (prospective and current), TFSVA staff and the TFSVA Board.

## **Membership Categories**

The TFSVA has the following categories of membership available:

#### **Full Membership**

Full membership is open to specialist family and sexual violence organisations and organisations that deliver services specific to family and/or sexual violence prevention, early intervention, response and/or healing and recovery in Tasmania.

All full members must endorse the purpose and principles of the Tasmanian Family and Sexual Violence Alliance Inc. and agree to adhere to relevant Practice Standards and quality standards, as endorsed by the Board.

#### **Associate Membership**

Associate membership has two categories:

<u>Category A:</u> organisations and government departments that endorse the purpose and guiding principles of the Tasmanian Family and Sexual Violence Alliance Inc. and have an interest in the work of the Tasmanian Family and Sexual Violence Alliance Inc.

<u>Category B:</u> individuals that endorse the purpose and guiding principles of the Tasmanian Family and Sexual Violence Alliance Inc. and have an interest in the work of the Tasmanian Family and Sexual Violence Alliance Inc. who are:

- Victim-Survivors and other people with lived experience of family and sexual violence;
  and/or
- engaged in specialist professional roles in family and/or sexual violence prevention, early intervention, response and/or recovery.
- students, researchers, academics, educators or practitioners with an interest in family and/or sexual violence prevention, early intervention, response and/or recovery.
- Community allies

## **Eligibility Criteria**

Membership applications to TFSVA are assessed, considered and approved or rejected by the TFSVA Board. Eligibility is assessed differently depending on the membership category an individual or organisation is applying for.

#### **Full Membership**

Full members must:

- be a specialist family and sexual violence organisation, or an organisation that is funded to deliver services specific to family and/or sexual violence prevention, early intervention, response and/or healing and recovery in Tasmania.
- endorse the purpose and principles of the Tasmanian Family and Sexual Violence Alliance Inc and commit to upholding the TFSVA Member Code of Conduct
- undergo an assessment against the TFSVA Practice Standards (currently in development) and be approved by the TFSVA Board

#### **Associate Membership - Organisational**

Organisational Associate Members must:

- be a registered organisation or government department
- endorse the purpose and principles of the Tasmanian Family and Sexual Violence Alliance Inc and commit to upholding the TFSVA Member Code of Conduct

#### **Associate Membership - Individual**

Individual Associate Members must:

- identify as an individual from one or more of the following member categories:
  - Victim-Survivor or has lived experience of family and sexual violence

- A specialist professional role in family and/or sexual violence prevention, early intervention, response and/or recovery.
- A student, researcher, academic, educator or practitioner with an interest in family and/or sexual violence prevention, early intervention, response and/or recovery.
- A community ally
- endorse the purpose and principles of the Tasmanian Family and Sexual Violence Alliance Inc and commit to upholding the TFSVA Member Code of Conduct

## **Application Process**

Application for membership can be made via the Membership Application Form available at <a href="https://www.tfsva.org.au/membership">www.tfsva.org.au/membership</a> (to be developed – add link). Full members are required to pay an application fee to cover the expenses of assessment.

## **Review / Approval Process**

The Board reviews applications and has the power to determine which individuals and organisations are eligible for each membership category. Applications for Full Membership are assessed against the Practice Standards and quality standards in line with the Constitution and as endorsed by the Board. The Membership Application Review Form is used to support this assessment, and organisations are required to provide written information and supporting documents (see Appendix 1). ## **Rights and Responsibilities of Members**

All members agree to abide by the Tasmanian Family and Sexual Violence Alliance Inc.'s rules and commit to the purpose, principles and roles and functions of the Tasmanian Family and Sexual Violence Alliance Inc.

Conditions of membership of the Tasmanian Family and Sexual Violence Alliance Inc. shall be in accordance with the board's relevant policies (including this policy), as amended from time to time.

Members must comply with The Tasmanian Family and Sexual Violence Alliance Constitution and the TFSVA Member Code of Conduct and must support the purpose and principles of the TFSVA.

#### **Voting Rights**

Full members hold voting rights at Annual General Meetings and Special meetings. Full members are also able to nominate a representative from the organisation to the Board. Each Full Member must appoint a Representative who will exercise the Full Member's voting rights.

## **Membership Fees**

Members pay an annual Membership Fee that is determined by the Board and is dependent on their class of membership. The current fee schedule can be found here: Membership - Tasmanian Family and Sexual Violence Alliance. The annual membership fee is due and payable on or before the first day of the financial year. Membership fees are not refundable.

The annual membership fee is calculated on a pro-rata basis depending on the month the member joins. If a member's payment fails they will be notified, and if payments fail for 5 months they cease to be a member, and all entitlements associated with membership are ceased.

#### **Record of Members**

The Public Officer will keep and maintain a Register of Members, including details such as but not limited to name, address, category of membership, date of membership commencement and invoice payment history.

## **Membership Renewal**

Membership will expire on 30 June each year. Membership and monthly repayments will automatically continue unless members resign as outlined below.

## **Membership Cessation**

Members may cease their Membership at any time by providing written notice to TFSVA via <a href="membership@tfsva.org.au">membership@tfsva.org.au</a>. The membership is considered ceased when the Board accepts the notice at a Board Meeting.

Members who fail to pay their membership fee within 5 months as outlined on their most recent invoice will also be considered as resigned.

## **Dispute Resolution**

Membership is managed in line with TFSVAs values, and as such issues raised with TFSVA regarding members will be approached in a timely, positive and supportive way with the aim of resolving the issue collaboratively.

## **Expulsion of Members**

If a more serious or ongoing breach of the member eligibility occurs, in line with The Tasmanian Family and Sexual Violence Alliance Constitution, the Board may expel a member from the Association if, in the opinion of the Board, the member is guilty of conduct detrimental to the interests of the Association. The Board will provide notice in writing to the member stating:

- that the Board has expelled the member
- specifying the grounds for expulsion
- informing the member of the right to appeal against the expulsion.

The member may appeal against expulsion in writing as outlined in The Constitution within 14 days. A special general meeting will be held within 21 days of receiving the request where the appeal can be heard the Board will vote on the expulsion.

## **Confidentiality and Privacy**

TFSVA is acutely aware that some victim-survivors wishing to be members will require high levels of confidentiality and privacy. TFSVA is committed to protecting the privacy and safety of all members. When you join or renew membership, we may collect personal information such as your name and contact details. We collect your information only for purposes related to your membership. We take reasonable steps to keep your information secure. Your data is only accessed by authorised staff or volunteers.
